REAL PROPERTY AGREEMENT

In constitution of Such loans and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BANK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and soverally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
 - 3. The property referred to by this agreement is described as follows: Mrs. W. H. Edwards, heirs and assigns ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Southwesterly side of Blythwood Drive, in the City of Greenville, South Carolina, being shown as the greater portion of Lot N. 12 on the plat of University Circle recorded in the R.M.C. Office for said County in Plat Book "Y", at page 111. and having according to said plat and survey made by P. M. Dalton dated page 111, and having according to said plat and survey made by R. W. Dalton, dated March 1954, the following metes and bounds, to wit:

BFGINNING at an iron pin on the Southwesterly side of Blythwood Drive, said pin being located 480 feet Southeast of the Southwesterly intersection of Blythwood Drive and Campbell Street, said pin also being the joint corner of Lots Nos. 11 and 12 and (a That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
