

TRACT NO. 1: ALL that lot of land with the buildings and improvements thereon, and furnishings therein, situate on the North side of Sunrise Drive at Caesar's Head in Cleveland Township, Greenville County, South Carolina, being shown as Lot No. 7 or plat of Section A of property of Paris Mountain-Caesar's Head Company, made by R. E. Dalton, Engineer, October 9, 1924, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book G, Pages 122 and 123, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING AT an iron pin on the North side of Sunrise Drive at joint front corner of Lots 5 and 7, and runs thence along the line of Lot 5, N. 27-40 E., 200 feet to an iron pin; thence S. 59-40 E., 99 feet to an iron pin; thence with the line of Lot 9, S. 26-27 W., 200 feet to an iron pin on the North side of Sunrise Drive; thence along the North side of Sunrise Drive, N. 59-40 W., 100 feet to the beginning corner.

This is the same property conveyed to Mary Ann Cannon by deed of Rose Waddill Moore, dated April 11, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 671, at Page 470.

TRACT NO. 2: ALL that certain piece, parcel or lot of land situated in Greenville County, South Carolina, in Cleveland Township on the north side of Sunrise Drive and having the following metes and bounds to-wit:

BEGINNING at an iron pin corner of lot formerly deeded to A. H. Cottingham N. 26-05 E. 200 feet to a stake; thence S. 65-0 E. 106 feet to a stake; thence S. 27-40 W. 200 feet to Sunrise Drive; thence N. 65-0 W. 100 feet to the point of beginning and being Lot #5, Section A Development, Caesar's Head.

This is the same property conveyed to Mary Ann Cannon by deed of Clifford I. Smith, dated May 23, 1962, recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 699, at Page 59.
