KNOW ALL MEN BY THESE PRESENTS, that I, Charles Boyd Cisson,

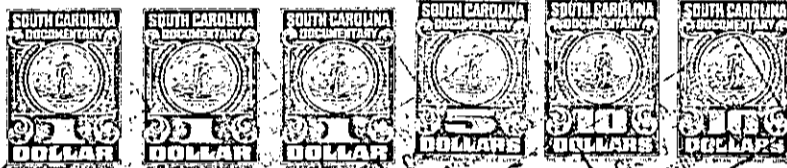
in consideration of Thirteen Thousand Nine Hundred Fifty and no/100-----Dollars,
