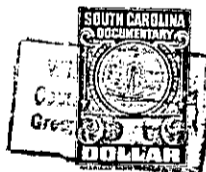
KNOW ALL MEN BY THESE PRESENTS, that I, Wanda Pruitt, Administrator for Aron C. Pruitt, Deceased

All that piece, parcel or lot of land in Bates Township, Greenville County, State of South Carolina, known as a part of the land conveyed to T. E. Coleman, Sr. by deed from Mrs. P. E. Coleman on the 23rd day of April, 1894 recorded in Book 23, Page 163, Adjoining lands of T. E. Coleman Sr. Estate on the west and Ebenezer Church land on the East and Lot No. 7 on the South.

Beginning on an i.p. corner of Lot No. 7 thence running N. 5 1/2 W. 20 feet tp i.p.. thence S. 84 1/2 W. 11 feet to an i. p. thence S. 5 1/2 E. 20 feet to i. p. thence N. 84 1/2 E. 11 feet to the beginning corner. The same being Lot No. 8 of a survey made by W. A. Hester in 1947.
