Earle Griffin, his heirs and assigns forever:

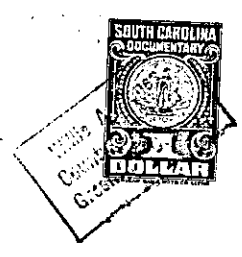
ALL of my undivided one-half interest in and to the following described land:
