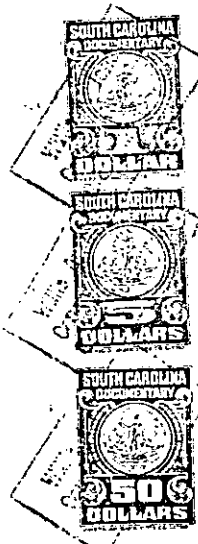
KNOW ALL MEN BY THESE PRESENTS, that I, Maurice B. Klingenberger,
