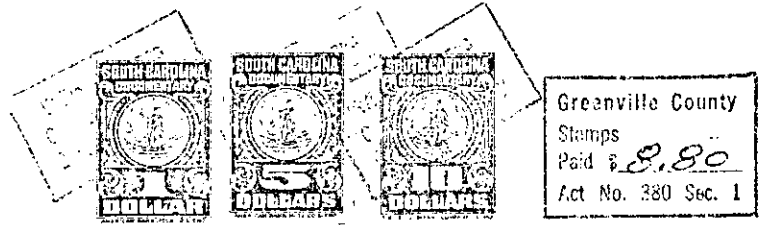

All that piece, parcel or lot of land situate, lying and being on the southern side of Greybridge Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 4 as shown on a plat of Trollingwood, Section 1, Revised, prepared by Enwright Associates and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at pages 12 and 13, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Greybridge Drive at the joint front corner of Lots Nos. 3 and 4 and running thence with the line of Lot No. 3 S. 4-20 W. 200.2 feet to an iron pin; thence with the line of property of Lake Trollingwood, Inc. S. 77-18 W. 120.0 feet to an iron pin; thence continuing with the line of property of Lake Trollingwood, Inc. N. 82-31 W. 81.6 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 N. 16-57 E. 267.4 feet to an iron pin on the southern side of Greybridge Drive; thence with the southern side of Greybridge Drive S. 72-05 E. 98.0 feet to an iron pin; thence continuing with the southern side of Greybridge Drive S. 76-25 E. 43.1 feet to the point of beginning.
