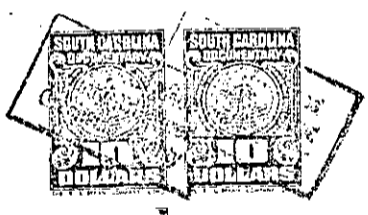

Office for Greenville County, and having the following courses and distances, to-wit:
