the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Terry G. Page & Judy B. Page their heirs and assigns forever.

All that certain piece, parcel, or lot of land with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 3 of a subdivision known as Woodruff Road Heights according to a plat thereof prepared by Jones Engineering Services dated April, 1971 and recorded in the R. M. C. Office for Greenville County in Plat Book 4G, at Page 159 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast side of Woodruff Road at the joint front corner of Lots Nos. 2 and 3, and running thence along the joint line of said lots, N. 40-35 E. 326 feet to an iron pin at the joint rear corner of said lots; thence along the rear line of Lots No. 3, N. 44-40 W. 180 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence along the joint line of said lots, S. 40-35 W. 326 feet to an iron pin at the joint front corner of said lots on the northeast side of Woodruff Road; thence along the northeast side of Woodruff Road, S. 44-40 E. 180 feet to the beginning corner; being the same conveyed to me by A.
