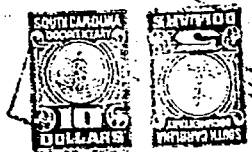

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **Marjorie M. Boone, Her Heirs and Assigns Forever:**

All that piece, parcel or lot of land situate, lying and being on the southern side of Greybridge Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 5 as shown on a plat of Trollingwood, Section 1, Revised, prepared by Enwright Associates and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4-R at pages 12 and 13, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the southern side of Greybridge Drive at the joint front corner of Lots Nos. 4 and 5 and running thence with the line of Lot No. 4 S. 16-57 W. 267.4 feet to an iron pin; thence with the line of property of Lake Trollingwood, Inc. N. 57-28 W. 155 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 N. 16-47 E. 228.2 feet to an iron pin on the southern side of Greybridge Drive; thence with the southern side of Greybridge Drive S. 72-05 E. 150 feet to the point of beginning.
