unto WALTER J. FARR, HIS HEIRS AND ASSIGNS:

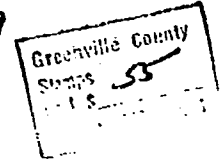
ALL that certain piece, parcel or lot of land situate, lying and being in the  
County of Greenville, State of South Carolina, consisting of a small strip along  
the Eastern side of Lowndes Avenue, as shown on a plat of Property of C. J.  
Hudson, et al, prepared on September 19, 1973, by C. O. Riddle, RLS, and  
having according thereto, the following courses and distancos:

BEGINNING at an iron pin on the Eastern side of Lowndes Avenue, and  
running thence N. 54-30 E. 3.4 feet to a point; thence S. 34-25 E. 75 feet to a  
point; thence S. 54-30 W. 6.82 feet to an iron pin; thence along said Avenue N.  
31-49 W. 75.14 feet to the beginning.
