KENNETH EDWARD PAYNE, His Heirs and Assigns:

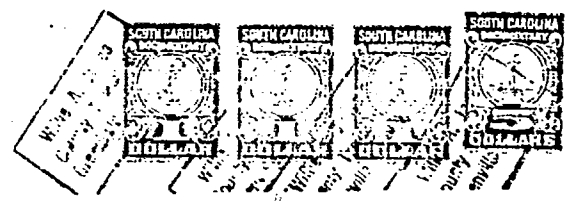

BEGINNING at a point on the Northeastern side of Driftwood Drive at the joint front corner of Lots 15 and 16 and running thence with the Northeastern side of Driftwood Drive S 34-41 E 139.5 feet to a point; thence following the curvature of the Northeastern side of a turnaround at the Southeastern end of Driftwood Drive S 64-41 E 50 feet to a point; thence continuing with the curvature of said turnaround S 4-41 E 50 feet to a point at the joint front corner of this lot and the property now formerly belonging to J.
