

ALL that piece, parcel or lot of land situate, lying and being on the west-ern side of Templewood Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 37, Section I, as shown on a plat entitled "Oak Crest", prepared by C.
