the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto MARCELLA S. McDANIEL and WYATT Y. McDANIEL, III, their heirs and assigns, forever:

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the Southern side of West Hillcrest Drive (formerly known as Findley Street), in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot No. 4 of Block J on a Plat of HIGHLAND TERRACE, Property of Hindman Development Addition, dated October, 1936, recorded in the RMC Office for Greenville County, S. C., in Plat Book K, pages 120 through 122, and having according to said plat the following metes and bounds, to-wit:

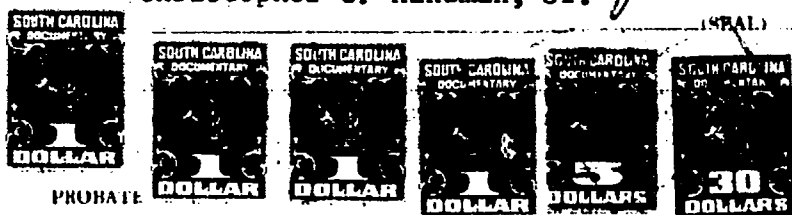
