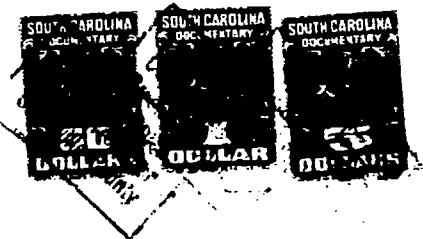
KNOW ALL MEN BY THESE PRESENTS, that Harold D. McAbee and Rochelle H. McAbee
