the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Gerald Bruce Hoover and Susan L. Hoover, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being on the southeastern side of Wood Drive near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as the property of Gerald Bruce Hoover and Susan L. Hoover on a plat prepared by Carolina Surveying Co. dated October 18, 1973 and according to said plat has the following metes and bounds, to-wit:

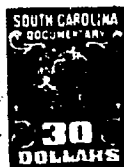
