a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the

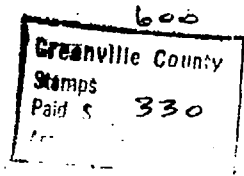
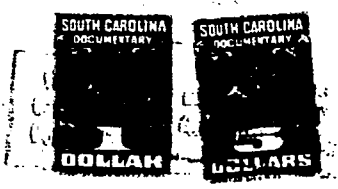

An undivided one-third (1/3) interest in and to all that certain piece, parcel, or lot of land, with the buildings and improvements thereon, lying and being on the southwesterly side of Foxcroft Road, near the City of Greenville, S. C., being known and designated as Lot No. 7 on plat entitled, "Final Plat Revised, Map No. 2, Foxcroft, Section II", as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4N, pages 36 and 37, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Foxcroft Road, said pin being the joint front corner of Lots 7 and 8, and running thence with the common line of said Lots S 73-38 W 150 feet to an iron pin, the joint rear corner of Lots 7 and 8; thence N 16-22 W 133.4 feet to an iron pin, the joint rear corner of Lots 6 and 7; thence with the common line of said Lots N 73-38 E 150 feet to an iron pin on the southwesterly side of Foxcroft Road; thence with the southwesterly side of Foxcroft Road S 16-22 E 133.4 feet to an iron pin, the point of beginning.

This conveyance is subject to a 25-foot sewer easement across the rear portion of the lot, and to all other restrictions, setback lines, roadways, easements and right of ways, if any, affecting the above described property.
