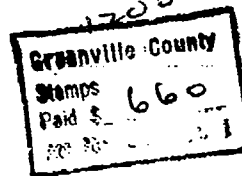
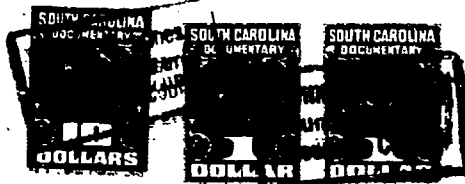
In consideration of Six Thousand and No/100 ----- (\$6,000.00) Dollars,
