KNOW ALL MEN BY THESE PRESENTS, that I, Ansel L. Robertson (same as Anclee L. Robertson),

in consideration of One Dollar, love and affection----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Dillie H. Robertson, her heirs and assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, near Oneal, and lying on the south side of the Jessie Bramlett Road, being bounded on the north by the said road and lands of Arden Brown, on the east by other lands of Jessie J. Bramlett, on the south by lands formerly of Walter Willamon and on the west by lands of P. M. Willbanks Estate, and being a part of the same land that was conveyed to Jessie J. Bramlett by deed from James L. Rollins, September 13, 1940, recorded in the Office of R.M.C. for Greenville County in Deed Book 225 at page 220, and having the following courses and distances, to-wit:

BEGINNING on a stake in the center of the said road, joint corner of the Arden Brown, Barnett and P. M. Willbanks Estate, and runs thence with the Willbanks line, S. 4-06 W. 428.5 feet to a stone and iron pin corner; thence with the Willamon line, S. 68-24 E. 407 feet to an iron pin on the said line, new corner; thence a new line, N. 19-27 W. 616 feet to a point in the center of the said road in line with the ditch that leads off from the culvert pipe; thence with the center of the said road, S. 87-46 W. 132.5 feet to the beginning corner, containing Two and Eighty-One One-hundredths (2.81) acres, more or less.

This being the same tract of land as conveyed to the Grantor herein by deed from Jessie J. Bramlett, dated June 12, 1956, and being duly recorded in the Office of R.M.C. for Greenville County in deed book 559 at page 328.
