to them in hand paid at and before the sealing of these presents  
by the grantee herein

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these  
presents do grant, bargain, sell and release unto the said South Carolina National Bank, as  
Trustee under a revocable trust agreement between it and  
the grantees dated October 22, 1973, its successors and  
assigns forever:

All that certain piece, parcel or lot of land situate, lying and  
being on the north side of Dill Street just outside the corporate  
limits of the City of Greenville, in the County of Greenville,  
State of South Carolina; and having, according to a survey made  
by Dalton & Neves, September, 1941, the following metes and  
bounds to wit:

Beginning at an iron pin at the northwest corner of the inter-  
section of Dill Street N 76-13 W., 99.4 feet to an iron pin at  
the corner of property of E. Howard; thence with said Howard  
line N. 14-52 E., 197 feet to an iron pin at corner of property  
of Kathleen Arnold; thence with said Arnold property S 79-12 E.,  
99.4 feet to an iron pin on the west side of Batson Alley;  
thence with the west side of Batson Alley, S 14-50 W.,

ALSO: All that piece, parcel or lot of land in Greenville
