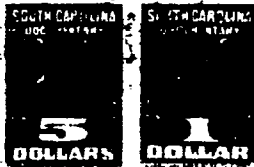
Cothran & Darby Builders, Inc., its successors and assigns forever; and undivided one-third (1/3) interest in and to:
