ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the southeast side of Perry Road, and being known and designated as a portion of Lot No. 3 of Block 1 of a Subdivision known as "Newland" as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book C, at Page 199 and having the following metes and bounds to-wit:

BEGINNING at an iron pin on the southeast side of Perry Road in the front line of Lot No. 3 which point is 20 feet southwest from the corner of Lot No. 4 and is also 154 feet from the intersection of Newland Avenue, and running thence along the southeast side of Perry Road N. 43-12 E., 6 feet to an iron pin in the front line of Lot No. 3 at a point 14 feet from the corner of Lot No. 4; thence on a line through Lot No. 3, S. 46-48 E., 150 feet to an iron pin on a 10 foot alley; thence along the line of said alley, S. 43-12 W., 6 feet to an iron pin in the rear line of Lot No. 3 at a point 30 feet from the rear corner of Lot No. 2; thence on a line through Lot No. 3 N. 46-48 W., 150 feet to the beginning corner.
