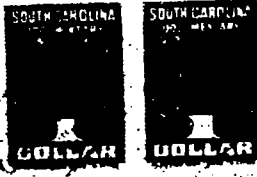
KNOW ALL MEN BY THESE PRESENTS, that we, Carl C. Moize, and May B. Moize,
