ALL MY RIGHT, TITLE AND INTEREST (The same being a one-half interest) in and to:

ALL that piece, parcel or lot of land situate, lying and being on the southern side of E. McBee Avenue in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot 1 on Plat of Joseph A. McCullough, et al., prepared by R. E.
