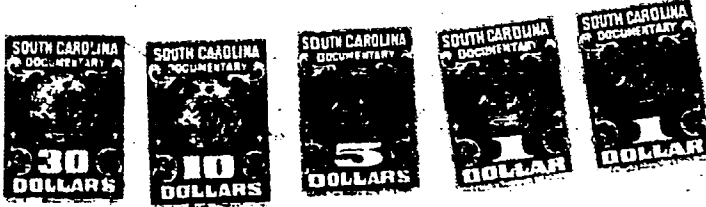
KNOW ALL MEN BY THESE PRESENTS, that American Development Co., a Partnership
