unto Jimmy M. Bridges, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 26 of a subdivision known as Woodruff Road Heights according to a plat thereof prepared by Jones Engineering Services dated April 1971, and recorded in the R. M. C. Office for Greenville County in Plat Book 4G at Page 159, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Lori Drive at the joint front corner of Lots 25 and 26, and running thence along the joint line of said lots, S. 60-41 E. 300 feet to an iron pin at the joint rear corner of said lots; thence S. 29-19 W. 220 feet to an iron pin at the joint rear corner of Lots Nos. 26 and 27; thence along the joint line of said lots, N. 60-41 W. 300 feet to an iron pin at the joint front corner of said lots on the southeastern side of Lori Drive; thence along the southeastern side of Lori Drive, N. 29-19 E. 220 feet to the beginning corner; being a portion of the property conveyed to me by Albert H. Marvill by deed recorded in the R. M. C. Office for Greenville County in Deed Vol. 688, at Page 133.

This conveyance is made subject to any restrictions, reservations, zoning ordinances or easements that may appear of record, on the recorded plat (s), or on the premises.

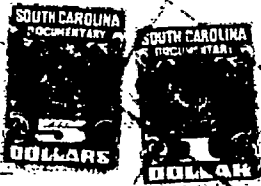
