


Whereas, the said Dan H. McKinney subsequently sold said property and it is now owned by Bobby G. McLeod and Mildred B. McLeod, and

McLeod and their heirs and assigns, all of her interest and estate, and all her right and claim of dower of, in and to all singular the premises known as Lot 4, Kenmore Terrace Sub-division, Greenville County, South Carolina, the plat of which said sub-division is recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book XX, at page 7 and as was set forth and described in that certain deed given to Dan H. McKinney and recorded in the R.M.C.
