to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

LONIE MAE GRASTIE CLAYTON, HER HEIRS AND ASSIGNS, FOREVER:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina in Chick Springs Township, designated as Lot No. 2 on plat of property of Ora Greene Kelly of record in the RMC Office for Greenville County in Plat Book EE, page 187 and having the following metes and bounds, to-wit:

BEGINNING at a pin on the south side of Pine Street at the northeast corner of Lot No. 1 and running thence with line of Lot No. 1, S. 7-36 W. 192.2 feet to a pin; thence S. 82-16 E. 18.3 feet to a pin; thence N. 56-02 E. 157.9 feet to a pin; thence N. 7-22 E. 111.3 feet to pin on south side of Pine Street; thence along the south side of Pine Street S. 83-34 W. 88.7 feet to a pin; thence still along said street, S. 84-49 W. 50 feet to the beginning corner.

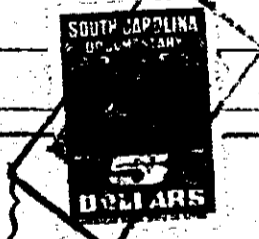

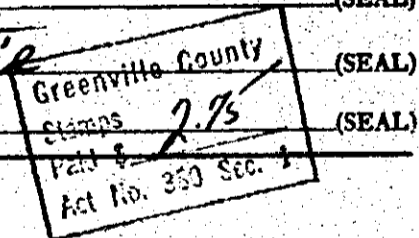
