KNOW ALL MEN BY THESE PRESENTS, that we, Lonita Boggs and Harriette Holmes,

in consideration of Forty Thousand Six Hundred Fifty (\$40,650.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SOUTH CAROLINA STATE HIGHWAY DEPARTMENT, its successors and assigns,

ALL that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being in the State of South Carolina, Greenville County, in the City of Greenville, lying on the northern side of Perry Avenue and having the following courses and distances as shown on a plat of the property of Ruth Kelly prepared by Piedmont Engineering Service dated March 22, 1954, recorded in the R.M.C. Office for Greenville County in Plat Book HH, page 19:

BEGINNING at a point on the northern side of Perry Avenue 214.1 feet in a southeasterly direction from the intersection of Perry Avenue and North Calhoun Street and running thence N. 19-50 E. 173 feet to an iron pin; thence N. 19-00 E. 236 feet to an iron pin; thence S. 71-00 E. 19.4 feet to an iron pin; thence S. 20-00 E. 201 feet to an iron pin; thence N. 71-00 W. 56 feet to an iron pin; thence S. 19-00 W. 80 feet to an iron pin; thence N. 71-00 W. 45 feet to an iron pin; thence S. 19-00 W. 173 feet to an iron pin on the northern side of Perry Avenue; thence with the northern side of Perry Avenue, N. 71-00 W. 48 feet to the point of beginning.
