the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **HENRIETTA H. HAMPTON, HER HEIRS AND ASSIGNS:**

ALL that certain piece, parcel or lot of land situate, lying and being in Dunklin Township, Greenville County, South Carolina, containing one (1) acre, more or less, on the Eastern side of Augusta Road, (U. S. Highway No. 25) and having the following courses and distances, to-wit:

BEGINNING at a point on the Eastern side of Augusta Road, located 105 feet South of the line of the W. V. Davenport Estate property, and running thence with the Augusta Road N. 51-30 W. 105 feet to the Davenport line; thence with the Davenport line N. 51-30 E. 420 feet to a point on the joint line of the Davenport and Ruff property; thence S. 51-30 E. 105 feet to a stake; thence S. 51-30 W. 420 feet to the point of beginning.
