ALL that lot of land in Greenville County, South Carolina, on the south side of Shoals Drive, being near the community of Cleveland, S. C., shown as Lot 4 on a plat of Silver Shoals, recorded in Plat Book MM, at page 35, and according to said plat described as follows:

BEGINNING at an iron pin on the south side of Shoals Dr., at the front corner of Lot 3 and running thence with the line of said lot S.18-00 E. 200.7 feet to an iron pin on the northern side of Silver Circle N. 72-15 E 80.02 feet to an iron pin at the corner of Lot 5; thence with the line of said Lot N. 18-00W. 189.4 feet to an iron pin on the south side of Shoals Drive; thence with the south side of Shoals Dr. S. 80-16 W. 80.9 feet to the beginning.

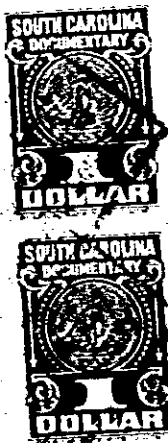
This being the same lot heretofore conveyed to the Grantor by deed recorded in Deed Book 868 Page 154.
