the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WINDMERE INVESTORS, A Limited Partnership, Its Successors and Assigns, forever; AN UNDIVIDED SIXTY (60%) PERCENT INTEREST IN AND TO THE FOLLOWING:

ALL of that lot of land, with the improvements thereon, in the County of Greenville, State of South Carolina, containing 4.84 acres, more or less, as shown on plat of Welcome Arms, A Partnership, recorded in the R. M. C. Office for Greenville County in Plat Book 4-W, at page 56, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Best Drive, which iron pin is situate 411 feet from the southern side of Easley Bridge Road, and running thence N 60-45 E 130 feet to an iron pin; thence S 89-47 E 482.8 feet to an iron pin; thence S 00-31 W 185 feet to an iron pin; thence S 48-58 W 161.9 feet to an iron pin; thence S 21-40 W 386.6 feet to an iron pin; thence N 29-15 W, the most of said property being along the northeastern side of Best Drive, 675 feet to the point of BEGINNING.

BEGINNING at an iron pin on the southern side of Welcome Road Extension 822 feet, more or less, East of the eastern side of Best Drive, and running thence S 00-31 W 384.3 feet to an iron pin; thence along the property of Welcome Arms Partnership, S 89-47 E 15 feet to an iron pin; thence N 00-31 E 384.3 feet to an iron pin on Welcome Road Extension; thence along Welcome Road Extension, N 88-04 W 15 feet to the point of BEGINNING.
