All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as part of Lot No. 29 in Block C, on a map of property of East Park, which is Boyce Lawn Addition, according to a plat thereof being recorded in the RMC Office for Greenville County, in Plat Book A at Page 383, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of East Washington Road at the intersection of East Washington Road with the C&W C.
