

26. Governing Law. It is the intent of the parties hereto that all questions with respect to the construction of this Agreement and the rights and liabilities of the parties shall be determined in accordance with the applicable provisions of the laws of South Carolina.

27. Variations in Pronouns. All pronouns and any variations thereof shall be deemed to refer to the masculine, feminine, neuter, singular or plural as the identity of the person or persons, firm or firms, corporation or corporations may require.

28. Agreement May be Executed in Counterparts. This Agreement and all Amendments thereto may be executed in any number of counterparts, all of which, taken together, shall be deemed to be a single agreement.
