All that certain piece, parcel or lot of land situate, lying and being in Butler Township, Greenville County, State of South Carolina, near the City of Greenville and according to Plat of Property of Lucy M. Cunningham, prepared by R.K. Campbell, dated December 9, 1959, being more particularly described as follows:
