the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto William E. Henderson, Jr. and Nancy E. Henderson, their heirs and  
assigns, forever:

ALL that piece, parcel or lot of land, situate, lying and being in the County  
of Greenville, State of South Carolina, and located on the southeastern side  
of Rosebrier Lane and being shown and designated as Lot No. 22 on a plat of  
Drexel Terrace, dated April 1, 1961, and prepared by Piedmont Engineering  
Service, recorded in the Office of the R.M.C. for Greenville County in Plat  
Book QQ at Page 177, and being more particularly described with reference to  
said plat as follows:

BEGINNING at a point on the southeastern side of the right-of-way of Rosebrier  
Lane, a joint front corner of Lot Nos. 23 and 22, and running thence S. 64-01  
E. 169.6 feet to a point; thence turning and running S. 22-36 W. 126.0 feet to  
a point; thence turning and running N. 63-26 W. 176.0 feet to a point; thence  
turning and running along the right-of-way of Rosebrier Lane N. 25-32 E. 124.0  
feet to the point of beginning.

Said lot is subject to a 35 foot building setback line, 10 foot drainage and  
utility easement along all side and rear lot lines, subdivision restrictions,  
rights-of-way and easements of public record affecting the property.
