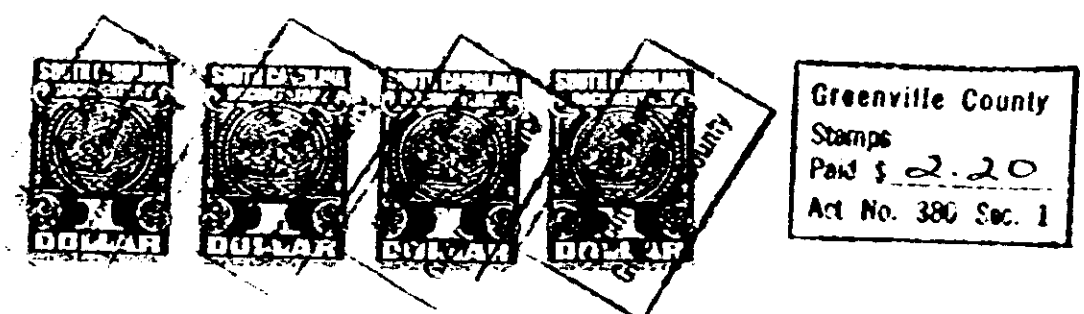
KNOW ALL MEN BY THESE PRESENTS, that **G & M Rentals, Inc.** -----
