ALL that piece, parcel or lot of land near Travelers Rest, Greenville County, State of South Carolina, and being shown and designated as Tract No. 3 on the Plat of the Property of P. B. Batson Estate prepared by W. R. Williams, Jr., R. E. & L. S. 73979, in October, 1973, and containing 9.87 acres, more or less, and according to said plat, having the following metes and bounds, to-wit:
