Don Owens, the owners and holders of that certain mortgage dated October 13, 1972 given by Fidelity Trust Corporation in the amount of \$145,550.00 recorded in mortgage volume 1253 page 313 of the RMC Office for Greenville County, S. C., hereby release and forever discharge from the lien and effect of said mortgage the following described parcel of land, being a portion of the back one-third of the total tract, as set forth on page 2, first paragraph 2 of the above named mortgage:
