- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under excrow agreement relating to said premises; and
 - 3. The property referred to by this agreement is described as follows:

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 2 on plat of Thomas Clifton Collins, unreworded, and having according to said plat and a recent survey made by R.W. Dalton, October 1957, the following metes and bounds, courses and distances, to-wit:

Beginning at in iron pin on the southeast side of Old Easley Bridge Road, the front joint corner of Lots 1 and 2; thence with the joint line of said lots S. 12-27 E.

352.5 feet to an iron pin corner of Lot No. 3; thence with the line of Lots 2 and 3, N. 38-13 W. 339.5 feet to an iron pin on the southeast side of Old Easley Bridge Road; thence with the southeast side of said Old Easley Bridge Road, N. 60-00E. 154.8 feet to the beginning corner. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
