in consideration of One Thousand One Hundred Thirteen and 64/100 (\$1,113.64) -----Dollars,

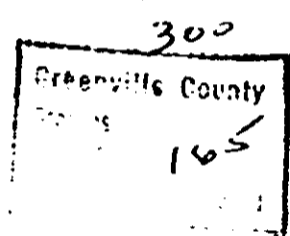
