JOHN WALLACE VASSAR and BARBARA McCOY VASSAR, their heirs and assigns forever:

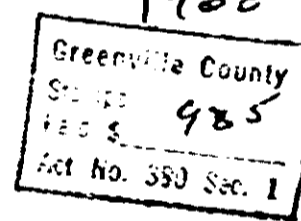
