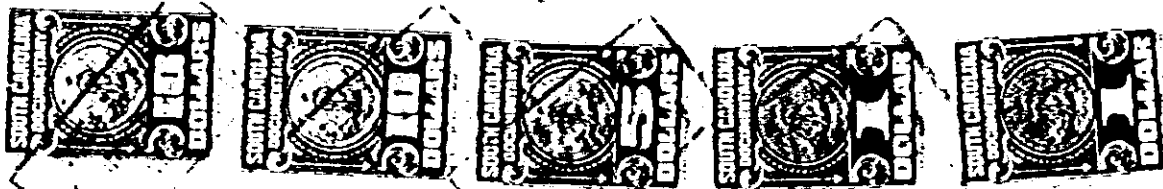
In consideration of Thirteen Thousand, Ninety and No/100-----(\$ 13,090.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Milton B. Howard, Jr. and Marilyn J. Howard, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 85 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D, pages 1 through 5 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Whittlin Way, joint front corner of Lots 84 and 85, and running thence with the joint line of said lots, N. 82-42 E. 169.76 feet to an iron pin; thence N. 10-40 E. 88.5 feet to an iron pin, joint rear corner of Lots 85 and 86; thence with the joint line of said lots, N. 84-54 W. 237.04 feet to an iron pin on the eastern side of Whittlin Way; thence with Whittlin Way, the following courses and distances: S. 28-20 E. 40 feet, S. 22-16 E. 50 feet, and S. 15-32 E. 50 feet, to the beginning corner.

This conveyance is subject to restrictions and covenants being recorded in the R. M. C. Office for Greenville County in Deed Vol. 991 at Page 10 as well as any other restrictions, rights-of-way or easements that appear of record, on the plat referred to above or as shown on the premises.
