In consideration of such leans and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BANK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Dunklin Township, and on the Western side of Cooley Bridge Road, being a portion of the property as shown on a plat of "Property of J. Guy Cothran and Thomas A. Cothran", dated June 12, 1963, and being more fully described as follows: BEGINNING at an iron pin on the Western edge of Cooley Bridge Road, 374.7 feet northerly from Beech Springs Road and running thence N81-26W 166 feet to an iron pin; thence N30-26W 100 feet to an iron pin; thence N29-12W 81.7 feet to an iron pin; thence N87-48E 295.8 feet to an iron pin on the Western edge of Cooley Bridge Road; thence along the Western edge of Cooley Bridge Road, S9-34W 97.7 feet to an iron pin; thence continuing along the Western edge of said Road, S11-12W 100 feet to the land the default to the reference of any time feet the state of the property and roof to the contain notes being the reference of any time feet, of the default of the property and does hereby assemble replaced over the roof and roof to over.

That if default to made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all intrite iness of the universigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and find the universigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Hank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
