the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James C. Lanning and Suzanne W. Lanning, their heirs and assigns forever:

ALL that piece, parcel or lot of land, with the improvements thereon, situate on the north side of Vanderbilt Circle, in the City of Greenville, Greenville County, South Carolina, being shown as Lot 42, on plat of White Oak Subdivision of Northside Development Company, made by J. D. Pellett, Jr., Engineer, August, 1946, recorded in the RMC Office for Greenville County in Plat Book P at Pages 120 and 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Vanderbilt Circle, which point is S. 74-34 W. 111.3 feet from the northwest corner of the intersection of Holmes Drive and Vanderbilt Circle, and is the joint front corner of Lots 41 and 42, and running thence with the line of Lot 41, N. 17-55 W. 140.7 feet to an iron pin; thence N. 53-45 W. 62.6 feet to an iron pin; thence S. 63-29 W. 47.7 feet to an iron pin; thence with the line of Lot 43, S. 39-11 E. 193.1 feet to an iron pin on the north side of Vanderbilt Circle; thence along the north side of Vanderbilt Circle, N. 67-07 E. 80 feet to the beginning corner.

This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights of ways appearing on the property and/or of record.

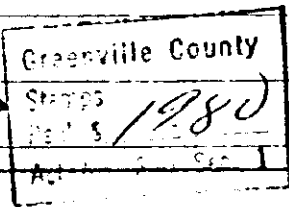
