(Jointly for Life With Remainder to Survivor)  
(FOR PURCHASE)

THIS WARRANTY DEED, made this 14th day of June, 19 74,  
between Jimmy C. Langston  
of Greenville County, State of South Carolina, Grantor(s);  
and Willie Sease, Jr. and Bessie Mae W. Sease  
of Greenville County, State of South Carolina, Grantee(s);

WITNESSETH: That the said grantor(s) for and in consideration of the sum of NINETEEN THOUSAND SIX  
HUNDRED AND NO/100 ----- Dollars (\$ 19,600.00 ),

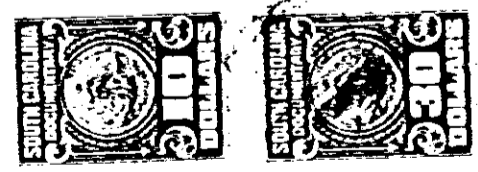
to me in hand paid by the Grantee(s), the receipt whereof is hereby acknowledged, has

granted, bargained, sold and conveyed and by these presents does hereby grant, bargain,  
sell and convey unto the said Grantee(s) for and during their joint lives and upon the death of either of them, then to the  
survivor of them, his or her heirs and assigns forever in fee simple, together with every contingent remainder and right of  
reversion, the following described land, lying and being in the County of Greenville  
State of South Carolina, to-wit:

ALL that certain piece, parcel or lot of land in the State of South  
Carolina, County of Greenville, near the Town of Simpsonville, being  
known and designated as Lot No. 24 on a Plat of Meadow Acres, Section  
2, prepared by Jones Engineering Service dated March 1, 1973, recorded  
in the RMC Office for Greenville County in Plat Book 5D at page 11,  
and having, according to said plat, the following metes and bounds, to  
wit:

BEGINNING at an iron pin on the southeastern side of Kennel Court at  
the joint front corner of Lots No. 23 and 24 and running thence along  
said Kennel Court, N. 45-15 E., 125 feet to an iron pin at joint front  
corner of Lots No. 24 and 25; thence S. 44-45 E., 211.3 feet to an  
iron pin; thence S. 39-08 W., 125.5 feet to an iron pin at the joint  
rear corner of Lots No. 23 and 24; thence N. 45-45 W., 225.5 feet to  
an iron pin, on the southeastern side of Kennel Court, being the point  
of beginning.

This property is conveyed subject to restrictive covenants of record,  
set back lines, road or passageways, easements and rights of way, if
