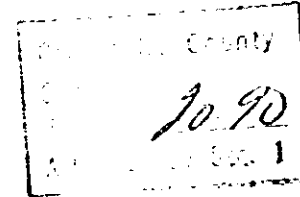
ALL that lot of land in Greenville County, South Carolina, known and designated
