KNOW ALL MEN BY THESE PRESENTS, that SOUTHLAND PROPERTIES, INC.

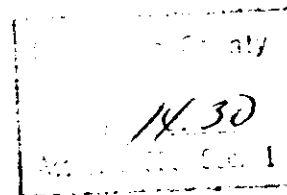
