All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the western side of Pine Ridge Drive, and being known and designated as Lot No. 12, as shown on a Plat of Plat 1, Section 2, Fresh Meadow Farms, made by Madison H. Woodward, Engineer, May 21, 1945, and recorded in the R. M. C. Office for Greenville County, in Plat Book "S", at Page 61, and having according to said Plat, the following metes and bounds, to-wit:

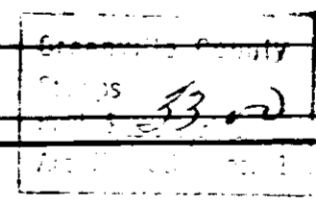
