KNOW ALL MEN BY THESE PRESENTS, that We, Eugene Mitchell and Lawtice B. Mitchell,

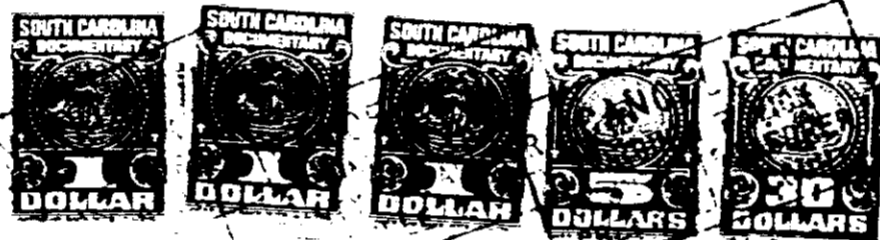
in consideration of Eighteen Thousand Nine Hundred and No/100 - - - - - (\$18,900.00) Dollars,
